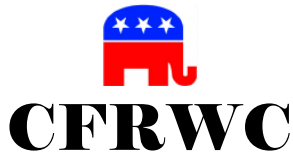


## **Minutes – by Linda Pearson, Corresponding Secretary**

### **MINUTES OF THE MAY 17, 2006 MEETING**

Lisa Macci opened the meeting at 7:05 p.m. Charlotte Kapp recited the prayer and Sandy Shull led the membership in the Pledge of Allegiance. Lisa introduced the guests in attendance. Dinner was then served. During dinner, Lisa read a 1907 quote on subject of immigration and led a short discussion on the issue. Following dinner, Lisa welcomed and introduced the guest speaker for the evening, County Commissioner, Mary McCarty. Mary has served as County Commissioner for the past 16 years and has not lost a campaign when running for office over the past 16 years. Mary explained that this year she will be facing a much greater challenge in her opponent, a 25 year old student from Chicago who attends Lynn University and who is being financially backed by his wealthy family. She stressed the great importance for grassroots support in her re-election bid. Mary also touched on the topic of identity theft and gave the members a handout explaining how to go online on the Clerk of Court website and request removal of personal information in the "Official Records Listing." Mary then addressed several other topics to include the county's preparations for hurricane season, the county's purchase of 27,000 acres of environmentally sensitive land and the opening of a therapeutic complex for special needs citizens at John Prince Park. Mary took several questions from the members. Sandy Shull, president of the Latin American Republican Women's Club Federated, addressed the members and thanked Lisa for inviting the Latin American Club members to join the meeting this evening.

The meeting was adjourned at 8:15 p.m.



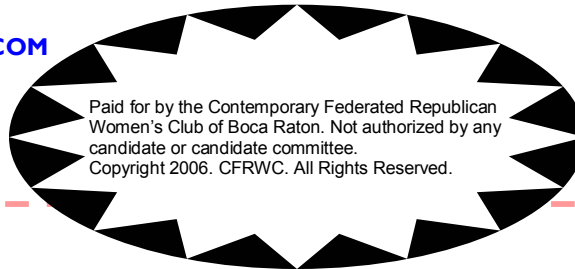
